Contractor shall ensure that Subcontractor's workmen (Operators / Drivers) provided under this subcontract are strictly under the legal sponsorship of M/s. Big Crane Light & Heavy Equipment & Import and Export and Spare Parts and that equipment provided are owned by the same, by providing copies of Civil ID's and Registration Certificates prior to mobilization at Site.
